Mayor Green commented that the Borough is going up 3.5 cents not 3.5%. Mayor Green stated that if the Borough had gone up the total amount it would have been 6 cents.

Mr. Davis asked about the resolution relating to the dual-band KA Radar as to what it was.

Mayor Green reported that it is the radar units for police cars.

Chief Winters explained that these radar units have the most recent technology.

Mayor Green explained that people have to sign up online at which point people can bid online when the Borough has the tax sale. Mayor Green reported that when people do not pay their taxes; then the Borough has a tax sale once a year. Mayor Green commented in the old days the Borough would put an ad in the paper and people would come into the Borough and bid on what was on sale; but when the tax sale is online bids are received from people all over the country. He stated that therefore, the Borough has a better chance with the tax sale.

Mr. Davis asked about Gov Deals and what the charge for the Borough would be.

Mr. Patterson explained that there would be no charge to the Borough because it is under state contract.
