INSTRUCTIONS:

- ✓ If you are licensing a pet for the first time, or renewing an existing license, complete the form and mail it, along with a copy of rabies certificate that is valid through November 1, of the licensing year, and a check or money order for payment, and mail it to 45 W. 7th Ave., Pine Hill, NJ, 08021, ATTN: Borough Clerk.
- ✓ Once received, the Borough Clerk will process and mail your new license and tag to the address you provide. Note: if the address you provide in the application does not match the address on file, the information will be updated in our system.
- ✓ If you are making notification of the fact that you no longer have your pet, or your pet is deceased, fill out the form per the above instructions and mail it back to 45 W. 7th Ave., Pine Hill, NJ, 08021, ATTN: Borough Clerk.
