Glass, cans, aluminum & plastic	Bottles, jars, cans, all plastic containers with #1 or #2 on bottom	In yellow recycling container	Regular collection day
Paper – mixed	Newspaper, magazines, office paper, cardboard	In yellow recycling container	Regular collection day
Vegetation	Brush, grass, leaves, branches	Branches-cut into 4 ft. lengths & bundled; leaves & grass in loose bags	Regular collection day
Leaves		Curbside pick-up April-May and Oct-Dec.	Per schedule in newsletter and on website
Scrap iron and metal	All metal objects, stoves, refrigerators, water heaters, heaters, washers, dryers, etc.	Place curbside and call for pick-up	Upon request
Electronics	TV's, Computers, printers, vacuum cleaners, coffee machines, electric fans, etc.	Place curbside and call for pick-up.	Upon request
Oil	Used motor oil from cars, trucks, mowers, etc., cooking oil	Call to set up appointment	Drop off at appt. time to 400 Davis Ave.
Tires	Car and truck tires with or without rims	Call to set up appointment	Drop off at appt. time to 400 Davis Ave.
Batteries	Car, truck, rechargeable	Call to set up appointment	Drop off at appt. time to 400 Davis Ave.
Batteries	Household	Regular trash	Regular collection day
Latex Paint	Open can, add cat litter or sand and allow to dry out.	Once can is dried out, put in regular trash	Regular collection day
Furniture	Mattresses, sofas, wood tables, etc.	Regular trash (Mattresses must be wrapped in plastic)	Regular collection day
Plywood, & misc. wood	Cut into 4 ft. lengths & bundled, free of nails, not weighing more than 50 lbs.	Regular trash	Regular collection day
Hypodermic needles	Put in sealed plastic container and mark "used syringes" and put in regular trash	Regular trash	Regular collection day
Medication	Prescription & over the counter	Put in drop box at Police Dept.	Drop off Mon.-Fri., 8:30 am – 4:00 pm
Carpet		Cut into 4 ft. lengths & bundled, not weighing more than 50 lbs.	Regular collection day
Glass panels & mirrors		Cover with cardboard and taped	Regular collection day

UPDATED GUIDELINES FOR OUR RECYCLING PROGRAM

Recycling processing facilities are now requiring that each delivered must not exceed certain levels of contamination. To simplify this new policy, we listed the new recycling rules on the opposite side of this letter.

WE ALL NEED TO WORK TOGETHER TO KEEP THE COST OF RECYCLING DOWN AND ENSURE THAT WE ARE RECYCLING THE MAXIMUM AMOUNT OF THE PRODUCT.

If the recycling loads collected from Pine Hill by our Outside Contractor are determined to be contaminated, The Borough would incur additional fees for the recycling from the Outside Contractor when they have to reload the recycling and take it to the trash disposal facility. This could create a very serious financial burden for us as taxpayers.

THE BEST WAY TO APPROACH THIS NEW PROCESS IS:

IF YOU ARE NOT SURE IF AN ITEM SHOULD BE RECYCLED OR IF YOU ARE NOT SURE IT IS CLEAN ENOUGH TO RECYCLE, PLEASE PUT IT IN THE REGULAR TRASH

We always want to recycle as much as possible, so please keep in mind, if a recycling load is contaminated with trash, we risk the entire load being rejected. This would not only result in an unnecessary financial burden, but could cause a substantial quantity of otherwise recyclable material, to be disposed of, and not recycled. The Borough relies on recycling grant money that is based on the success of its recycling program. We ask that you please do your part with this effort.

GUIDELINES FOR THE PINE HILL RECYCLING PROGRAM

***** DO NOT PUT RECYCLING ITEMS IN PLASTIC BAGS OF ANY COLOR OR SIZE*****

BEFORE PLACING ITEMS IN THE YELLOW CAN:

EMPTY AND RINSE

(Please get them as clean as possible)

DO NOT CRUSH BOTTLES OR CANS

ACCEPTABLE ITEMS FOR THE YELLOW RECYCLING CANS

- PLASTIC CONTAINERS WITH A NUMBER 1 OR 2 ON THE BOTTOM—LEAVE CAPS ON
 - GLASS BOTTLES AND JARS—REMOVE LIDS AND PUT THEM IN THE YELLOW BUCKET
 - METAL CANS—NEWSPAPER—CARDBOARD

UNACCEPTABLE ITEMS FOR THE YELLOW RECYCLING CANS

- PLASTIC CONTAINERS THAT DON'T HAVE A 1 OR 2
- CONTAINERS THAT ARE NOT RINSED OUT
- NO PIZZA BOXES OR OTHER CARDBOARD ITEMS WITH FOOD RESIDUE
- NO FROZEN FOOD CONTAINERS—THESE ARE COATED AND NOT RECYCLABLE
- NO CERAMICS, LIGHT BULBS, WINDOWS OR MIRROR GLASS
- NO SHREDDED PAPER—Please bring confidential documents to a free Camden County or Pine Hill Shredding Event or place already shredded paper into the regular trash.
- NO HAZADROUS WASTE CONTAINERS—Motor Oil, Pesticides, Chemicals, etc.
- NO SCRAP METAL
- NO DIAPERS OR BIO-HAZARDSOUR WASTE
- NO PLASTIC BAGS IN THE YELLOW RECYCLING CANS—Please take them to the local stores that have collection bins for the bags or place into the regular trash
- NO YARD WASTE IN THE YELLOW RECYCLING CANS

If you are not sure about an item, it would be best to put it in with the regular trash.

WHEN IN DOUBT THROW IT OUT
